## 2. Principal / Assistant Principal's Items

 Mrs. Byrom presented Positive Behavioral Interventions and Supports (PBIS) at CES (reboot for 2023) - reward system for students (Mrs. Byrom will share presentation via School Messenger)

### 3. President / Vice President Items

- Policies for Meetings
  - Communication primarily through email (sign-up for newsletter via cespta.net)
  - Committees can be joined by signing up via email or at a PTA meeting
  - Audio and video recording at PTA meetings is not permitted without express consent from all in attendance
  - PTA meetings will follow the agenda distributed prior to the start of the meeting; time allotted at end of each meeting (Q&A period)
  - Discussion: consider hybrid meeting; send agenda ahead of time and add to PTA website. Eileen shared that there are plans for alternating virtual meetings with in-person meetings.
- Approval of Minutes May

- o IRS Status Update
  - CES PTA lost 503(c)(3) charitable / non-profit status
    - Maryland PTA separated from National PTA; CES PTA previously voted to join Free State PTA; Maryland PTA removed CES PTA from tax-exemption; Free State PTA pending to be added to group exemption from IRS
    - 2. CES PTA filed Form 990 but rejected by IRS; CES PTA plan to file Form 1128 (change fiscal year to previous fiscal year)

- Next steps:
  - 1. Recommend families and teachers interested in joining PTA hold off on donations / payment until IRS status resolved (exception: per bylaws, PTA board members and committee leads need to pay dues by 9/30)
  - 2. Discussion: if vote needed at next meeting to discuss option of separating from FreeState PTA, request to share pros and cons of Free State PTA vs. starting own Parent-Teacher non-profit organization
- Micaela Crooks asked for a motion to give Eileen and Meghan time until 10/24 (next PTA meeting) to figure out IRS status (with free support of CES families) before hiring outside CPA. Amie Leone seconded. A voice vote was called with no opposition, the motion carried.
- o Back to School BINGO Wednesday, September 27th
  - Need volunteers Pizza, Spirit Wear?, Daubers/bingo cards, callers
  - Need microphone and speaker Cathy has equipment for backup
- Calendar for the year
  - Discussion of proposed dates and events
  - Fun Run discussion of date and whether to keep it as a fundraiser. Preference is to keep it as a fundraiser.
    - 1. Eileen Brewer asked for a motion to hold Fun Run in November; Meghan Nickerson seconded. A voice vote was called with no opposition, the motion carried.
